*Important Notice!

Customers that wish to block delivery of their Caller ID information to called parties may do so by dialing *67 on a per call basis.

Customers that have **permanently blocked** delivery of their Caller ID information may "deliver" their information by dialing *82 on a per call basis.

If you have any questions about blocking/unblocking your Caller ID information, please contact our office and we will help you find a solution that best meets your needs.

Block the Blocker

Block the Blocker blocks all calls from parties who have used a privacy feature to prevent delivery of their Caller ID information. "Anonymous" or "Private" calls won't even ring. (Unavailable, Out-of-Area, and displayed calls will be completed as usual.)

To Use Block the Blocker

- 1. Press ***77** to activate.
- 2. Press *87 to deactivate.

Call Forwarding

This feature means that your phone can transfer incoming calls to another number of your choice. Call forwarding is great for the business person who wants to catch after-hours business calls at home, or for anyone who doesn't want to miss an important call.

To Forward Your Calls

- 1. Press *72.
- 2. Listen for dial tone.
- 3. Enter the number where you wish your calls forwarded.
- 4. Advise party of Call Forwarding. If the party does not answer or if the line is busy:
 - Repeat step 1 & 2.
 - · Listen for three beeps and a steady dial tone.
 - · Hang up.

Once you have activated Call Forwarding, the phone will make one short ring each time a call is forwarded. This is just a reminder that all your calls are being forwarded. You can still make out-going calls from this phone without interfering with incoming calls.

How to end Call Forwarding

1. If you wish to change the number your calls are being transferred to, just push *73 to deactivate. You may now repeat the Call Forwarding procedure.

Call Forwarding-Busy

You can automatically forward your calls to another number when your phone line is in use. Calls can be forwarded long distance* with this feature. You can activate, deactivate, and program forward-to numbers from your phone.

How to use Call Forwarding-Busy

- 1. Press *90. Listen for dial tone.
- 2. Enter the number to which the calls are to be forwarded.
- 3. When someone answers, Call Forwarding-Busy is activated. If the number you called is busy, or if there is no answer, hang up and repeat the previous steps within two minutes. Wait for three beeps and steady dial tone to confirm activation, then hang up. Call Forwarding-Busy is activated. From that moment on, all calls will go to that number until you change the number or end Call Forwarding-Busy.

To end Call Forwarding-Busy

- 1. Press ***91**.
- 2. Listen for busy signal, then hang up.

^{*}Toll charges apply if you forward calls to a long distance number.

Call Forwarding-No Answer

This feature allows you to forward your calls to another number when you are not at home or unable to answer your telephone. You may answer the call, or if unanswered after your specified number of rings, the call will forward to your forward-to number.* You can activate, deactivate and program the forward-to number from your phone.

How to use Call Forwarding-No Answer

- 1. Press *92.
- 2. Listen for dial tone.
- 3. Enter the number to which the calls are to be forwarded. When someone answers, Call Forwarding-No Answer is activated. If the number you called is busy, or if there is no answer, hang up and repeat the previous steps within two minutes. Wait for three beeps and steady dial tone. Call Forwarding-No Answer is activated. From that moment on, all calls will go to that number until you change the number or end Call Forwarding-No Answer.

How to end Call Forwarding-No Answer

- 1. Press *93.
- 2. Listen for three short beeps, then hang up. Your Call Forwarding-No Answer is no longer active.

Caller ID with Caller Name

Caller ID lets you see the calling party's name and phone number before answering a call. A special display device located on or next to your phone is required to allow you to view the calling number.

- 1. Wait for the start of the second full ring of your phone set.
- 2. The number of the calling party will appear on your display device.

For more information, please refer to the instructions for your Caller ID display device.

Call Return

Call Return allows you to dial a code and have a call automatically returned to the last party who called or attempted to call you.

To Use Call Return:

- 1. Press *69.
- 2. Listen for an announcement that will tell you the phone number of the party who last called you.
- 3. If you wish to return the call:
 - Press 1.
 - · Listen for ringing.
 - · Wait for answer.
- 4. If you do not wish to return the call, hang up.
- 5. If the line is busy:
 - Listen for announcement telling you the number is busy.
 - Hang Up.
 - You will hear a short-short-long ring when the line is free.
 - Your call will automatically be made when you lift the handset.

To Cancel Call Return:

1. Press ***89** and listen for tone or announcement.

Notes:

a. There is no time limit for returning a missed call. However you will only be able to return the last incoming call you receive. Call Screening allows you to create a list of phone numbers from which you do not wish to receive calls. Calls from your "list" will hear a polite recording stating that you are not accepting calls at this time.

Call Screening

To Use Call Screening

- Press *60.
 - Listen to the voice instructions which will guide you through the steps of how to set-up your list and turn Call Screening on or off.

Call Waiting

If you have an incoming call while you're already on the line, the Call Waiting feature will alert you. You may then put the first party on hold while you catch your second call. It will greatly reduce missed calls due to a busy phone!

Here's How Your Call Waiting Feature Alerts You

- · A beep tone tells you another call is waiting. Only you hear this tone.
- Another reminder tone will be heard 10 seconds later if the waiting call remains unanswered.
- The second caller hears the normal ringing tone only.

To Answer the Second call

- Depress the switchhook/plunger for about one second to place your first call on hold.
- You will automatically be connected with the second caller.

To Alternate Between Calls

- By depressing the switchhook/plunger for about a second, you may alternate between calls.
- Each conversation is private and cannot be heard by the other caller.

To Terminate Either Call

- · Simply hang up.
- · Your telephone will then ring.
- When you answer it, you'll be connected with the other caller.

Cancel Call Waiting

To Disable the Call Waiting Tone for the Next outgoing Call only:

- · Lift receiver and listen for the dial tone.
- For push button (tone) lines, dial *70.
- Call Waiting is now disabled and dial tone is returned.
- Dial the number on which you wish to not be disturbed by a Call Waiting tone.
- Termination of the call reestablishes the Call Waiting tone on all calls thereafter.

Call Waiting ID

Call Waiting ID brings you the benefits of both Caller ID and Call Waiting. When your telephone line is idle, incoming calls will ring with the calling party's number (and name, if available). In addition, if you are on the phone and receive a Call Waiting tone, you may look at your Caller ID display and see the number (and name, if available) of the calling party. If you wish to answer the Call Waiting call, you may simply hook flash or hang up on the first call to answer the Call Waiting call.

Do Not Disturb

This feature allows you to "turn off" your phone when you do not wish it to ring. Callers will hear a busy signal. If you wish, you may enter a special passcode which will allow only certain callers to get through.

While your phone is on Do Not Disturb, you may still make (outgoing) calls.

Only those callers who know your special passcode will be able to get through.

To Activate Do Not Disturb

Lift the receiver and push 3 buttons, *78. You will hear two (2) short beeps. Hang up. Your phone will not ring. Those callers who have been given your special passcode can push your four number passcode to ring through.

To Deactivate Do Not Disturb

Lift the receiver, and push three buttons, *79. Wait to hear two beeps, and hang up. Your phone will operate in a normal manner.

Preferred Call Forwarding

Preferred Call Forwarding allows you to create a list of phone numbers that are to be forwarded when they call you. When you activate this feature, and a call arrives from a phone number that is on your list, the call is forwarded. All other calls will ring your phone in the normal fashion.

To use Preferred Call Forwarding:

- 1. Press *63.
- 2. Listen to the voice instructions which will guide you through the steps of how to:
 - Turn Preferred Call Forwarding on or off.
 - Make changes to your Preferred Call Forwarding list.

Press	If you want to:
0	Repeat the instructions.
1	Review the numbers on your Preferred Call Forwarding list.
3	Turn Preferred Call Forwarding on/off.
#	Add a number to your Preferred Call Forwarding list.
*	Delete a number from your Preferred Forwarding list.
08	Delete all numbers from your Preferred Call Forwarding list.

3. Voice instructions will also guide you through the steps of how to enter, confirm or change the number to which your calls will be forwarded.

Press	If you want to:
*	Confirm the forward-to number.
08	Change the forward-to number.

Priority Ringing

Priority Ringing allows you to program your telephone line to ring with a special ringing pattern whenever you are called from a select list of phone numbers. Your phone will ring with a normal ringing pattern for all other calling numbers. If you also have Call Waiting, you will hear a distinctive Call Waiting tone whenever someone on your list calls you while you are on the phone.

To Use Priority Ringing:

- 1. Press
- 2. Listen to the voice instructions which will guide you through the steps of how to:
 - Turn Priority Ringing on or off.
 - · Make changes to your Priority Ringing list.

Press	If you want to:
0	Repeat the instructions.
1	Review the numbers on your Priority Ringing list.
3	Turn Priority Ringing on/off.
#	Add a number to your Priority Ringing list.
*	Delete a number from your Priority Ringing list.
08	Delete all numbers from your Priority Ringing list.

When Priority Ringing is Turned on:

Listen to the ringing pattern or Call Waiting tones:

•	When called from any number on your list	A short-long-short ringing pattern or tone
•	When called from any other number	Normal ringing or Call Waiting tones

Repeat Dialing

Repeat Dialing allows you to dial a code to have your phone continuously attempt to redial a busy number that you tried to call. When the line is free, you will be alerted with a special ringing, and a call will automatically be made. You can also use Repeat Dialing to redial the last number you called.

To use Repeat Dialing:

- 1. Hang up, then lift the receiver and listen for dial tone.
- 2. Press *66.
- 3. If the line is busy:
 - Listen for three beeps or an announcement telling you the number is busy.
 - Hang up.
 - You will hear a short-short-long ring when the line is free.
 - · Your call will automatically be made when you lift the handset.
- 4. If the line is not busy:
 - · Listen for ringing.
 - · Wait for answer.

To cancel Repeat Dialing:

1. Press *86 and listen for tone or announcement.

Notes:

- a. While Repeat Dialing is activated, you may still make and receive other calls.
- b. Repeat Dialing will continuously attempt to call back a busy number for 30 minutes. After 30 minutes, your request will be canceled.
- c. You can use Repeat Dialing for more than one busy number at a time. You will hear a special ring when one of these numbers becomes idle; however, you will not be able to tell which of the numbers it is.
- d. If the number you are trying to reach is outside the area served by Repeat Dialing, you will hear a recording advising you that the call cannot be made.

Secure Access

Secure Access allows you to prevent long distance calls from being made from your telephone line. It can be overridden on a per call basis by dialing a special access code plus your PIN.

Incoming and local calls are not affected by activation of this feature.

To Make a Long Distance Call

- 1. Lift the receiver and listen for dial tone.
- 2. Press **1** + the long distance number. Listen for dial tone.
- 3. Dial your PIN code.
- 4. Call will then connect.

Notes:

- a. If you dial an invalid access code and/or PIN, you will hear an announcement to try again.
- b. Toll restriction is automatically returned each time you go back to the hook.

Special Call Acceptance

Special Call Acceptance allows you to screen incoming calls by creating a list of phone numbers from which you are willing to accept calls. Calls from numbers not contained on your list are sent to an announcement that informs the caller that you are not receiving calls at this time.

To use Preferred Call Forwarding:

- 1. Press *64.
- 2. Listen to the voice instructions which will guide you through the steps of how to:

Delete all numbers from your Preferred Call Forwarding list.

- Turn Preferred Call Forwarding on or off.
- Make changes to your Preferred Call Forwarding list.

Press If you want to: Repeat the instructions. Review the numbers on your Preferred Call Forwarding list. Turn Preferred Call Forwarding on/off. Add a number to your Preferred Call Forwarding list. Delete a number from your Preferred Forwarding list.

3. Voice instructions will also guide you through the steps of how to enter, confirm or change the number to which your calls will be forwarded.

Press	If you want to:
*	Confirm the forward-to number.
08	Change the forward-to number.

Speed Calling 8

Now you can call up to 8 of your most frequently dialed numbers just by dialing a one-digit code. This includes long distance numbers.

To Establish Your Speed Calling List

- · Lift the receiver and listen for dial tone.
- · Dial *64.

08

- Then depress the # button.
- · Again, listen for dial tone.
- Dial one of the 8 one-digit access code numbers (2-9).
- Then dial the number you wish to Speed Code. (For long distance entries, dial **1** and then the area code before the number.)
- Then depress the # button.
- Listen for confirmation tone to indicate your Speed Calling number is established.

At any time you may repeat this process for each number you wish to Speed Code, assigning each a different code number.

To Use Your Speed Calling Feature

- · Lift the receiver and listen for the dial tone.
- Dial the appropriate one-digit access number (2-9).
- Push the # button.

To Change Your Speed Calling List

Simply follow the same steps for establishing your list. A new number automatically cancels out the corresponding existing number.

Speed Calling 30

Now you can call up to 30 of your most frequently dialed numbers just by dialing a two-digit code. This includes long distance numbers. It's a real time saver!

To Establish Your Speed Calling List

- · Lift the receiver and listen for dial tone.
- · Dial *75.
- · Again, listen for dial tone.
- Dial one of the 30 two-digit access codes numbers (20-49).
- Then dial the number you wish to Speed Code. (For long distance entries, dial **1** and the area code before the number).
- Then depress the # button.
- Listen for confirmation tone to indicate your Speed Calling number is established.

At any time you may repeat this process for each number you wish to Speed Code, assigning each a different code number.

To Use Your Speed Calling Feature

- Lift the receiver and listen for the dial tone.
- Dial the appropriate two-digit access number (20-49).
- Push the # button.

To Change Your Speed Calling List

Simply follow the same steps for establishing your list. A new number automatically cancels
out the corresponding existing number.

S.T.O.M.P. (Stop Telemarketers On My Phone)

S.T.O.M.P.

Want to stop annoying telemarketers calls? Well now you can. STOMP prevents your phone from ringing when a telemarketer tries to call. When STOMP is activated all callers will hear a recorded message advising them that you do not accept calls from telemarketers. All other callers can complete the call by pressing **3**. Telemarketers must honor your request by terminating the call and adding your phone number to their do not call list.

Service not compatible with Basic Do Not Disturb.

Three Way Calling

This feature lets you turn an everyday two-way phone call into a three-way conversation. It's easy!

To Add A Third Party Call:

- First, to hold your existing call, quickly depress and release the switchhook/plunger button. (Be sure to depress and release quickly!)
- Then dial the third number. (Speed calling codes may be used if you also have this feature.)
- When the third party answers, you may talk privately before completing your three-way connection.
- With your third party on the line, depress the switchhook/plunger for a second time to add the holding party. Your Three Way Call is now in effect.

If for some reason the call to the third party is not completed, depress the switchhook/plunger twice to get back to your held party.

To Disconnect the Third Party

• Depress the switchhook/plunger for a second. You will now have only the original party on the line.

To Disconnect Completely

- · Simply hang up.
- If either of the two parties hangs up, you can continue to talk to the one remaining.

Voice Mail

Setting-up your Voice Mail service

The first time you access your voice mail you will be asked to create a password, record your name, and create or select a greeting to be heard by callers.

Changing your Password

- Press *-9-8 to access voice mail from your telephone handset
- Press 4 to change your settings, from the main menu
- Press 3 for security options
- Press 1 to change your PIN

Recording your Greeting

- Press *-9-8 to access voice mail from your telephone handset
- · Press 3 from the main menu
- Press 1 to set up your personal greeting
- · A generic greeting will play until you record a personal greeting

Message Waiting Indicators

When you have unheard voice messages waiting, you will hear a "stutter dialtone" when you pick up your telephone handset. Some telephones may also display a red light to indicate you have a message waiting.

Retrieving your voice mail from your phone:

- Press *-9-8
- Enter your password
- After listening to new messages, you will be presented with the Voice Mail Main Menu. The main menu
 options are listed below.

Retrieving your voice mail from another phone:

- · Enter your home number.
- Press * when you hear your greeting
- Enter your password and follow the voice prompts

General Information

BUSINESS OFFICE

All matters relating to new telephone service, changes of address, termination of service, adjustments of accounts, collection of bills, etc., are handled in the Business Office of the Company.

TARIFFS, RULES AND REGULATIONS

The tariffs, rules and regulations of this Company are on file in the Business Office of the Company and may be inspected upon application. A representative of this Company will lend any assistance necessary in securing information from such tariffs.

LOCAL SERVICE

Local service is furnished for the primary use of the subscriber, members of his firm or family, employees, guests or joint users.

TOLL SERVICE

Subscribers are responsible for all long distance service originating from or made collect to their telephones, regardless of who places or talks on the calls.

BILLS AND PAYMENTS

Telephone bills are mailed monthly. They cover local service charges and directory advertising service in advance for a one-month period from the date of the bill and long distance service charges for approximately a one-month period in arrears. Bills are due when rendered. We ask your cooperation in the prompt payment of all amounts due

CHANGES OF TELEPHONE NUMBERS

Changing telephone numbers is unavoidable and we realize that it results in some inconvenience to our customers. To meet the increasing use of telephone service by customers, however, and in

order to provide for new and additional service, rearrangements in our plant are sometimes necessary. Your cooperation in such readjustments will be appreciated. In case telephone numbers are used on your stationery, vehicles or other forms of advertising, it will be to the best interest of your service to keep them currently correct.

CHANGES OF ADDRESS

Subscribers desiring telephone equipment rearranged or service moved from one address to another should notify the Business Office at least ten days in advance. Notification as to new directory listings should be made by subscribers, preferably in writing, to the Business Office of the Company.

INCORRECT DIRECTORY LISTINGS

The vast majority of all directory listings are correct. But, as with any job of this size, some errors are bound to occur. If your listing in the directory is incorrect, it cannot be changed until the next edition of the directory is issued. In the meantime, we can make sure the listing is correct in Directory Assistance records. In some cases it is possible for calls to an incorrect number to be rerouted to the correct number. To arrange this, call your telephone business office. The number is on your phone bill and in the front of your telephone directory. Your service representative will be happy to help.

INTERRUPTIONS OF SERVICE

When requested by the subscriber, if service is continuously interrupted for more than 48 hours, and for causes other than negligence or willful act of the subscriber, an allowance shall be made, at the minimum rate for the telephone facilities and class of service affected by the service interruptions, for such time as the interruption continues. No other liability shall attach to the Company on account of such service interruptions.

OBSCENE AND HARASSING CALLS

Every person who shall by means of telephone communication:

- $(a) \quad \text{make any comment, request, suggestion or proposal which is obscene, lewd, lascivious, filthy, or indecent; or a suggestion of the contraction of the contra$
- (b) make a telephone call, whether or not conversation ensues, without disclosing his identity and with intent to annoy, abuse, threaten, or harass any person at the called number; or
- (c) make or cause the telephone of another repeatedly to ring, with intent to harass any person at the called number, or
- (d) make repeated telephone calls during which conversation ensues, solely to harass any person at the called number; or
- (e) play any recording on a telephone except recordings such as weather information or sports information, when the number thereof is dialed, unless the person or group playing the recording shall identify itself or himself and state that it is a recording; or
- (f) knowingly permit any telephone under his control to be used for any of the purposes mentioned herein.

shall be guilty of a misdemeanor and shall upon conviction thereof be punished by a fine of not more than two thousand five hundred dollars (\$2,500.00) or by confinement for not more than one year in the county jail, or by both such fine and confinement.

INTENT TO DEFRAUD

It shall be unlawful for any person to obtain or attempt to obtain, by the use of any fraudulent scheme, device, means or method, telephone or telegraph service or the transmission of a message, signal or other communication by telephone or telegraph facilities with intent to avoid payment of the lawful price, charge or toll therefore. Any person who violates any provision of this statute is guilty of a misdemeanor and upon conviction shall be punished by confinement in the county jail for not more than one year or by fine not exceeding one thousand dollars, or both such fine or confinement.

The opportunity to be heard

Complaints

Your service representative is available to answer your questions and resolve your problems. If you're not satisfied, fell free to ask for a supervisor. If your problem can't be solved by the supervisor, ask for the manager or higher levels of management.

If you still are not satisfied, you have the right to file a formal or informal complaint with the Kansas Corporation Commission, which regulates Kansas Telephone Companies.

When dialing person-to-person, collect, calling card and billed to another number.

Within the 620 area...Dial "0" (Operator) + 620 + seven digit telephone number Outside the 620 area...Dial "0" (Operator) + area code + seven digit telephone number

After you have dialed the number, an operator will answer and request the details necessary to complete your call.

Special Notice Regarding "900" Numbers

900 numbers are billed on a pay-per-call basis. Wheat State Telephone acts as a billing and collection agent for many providers of such services.

Wheat State Telephone automatically blocks access to all 900 numbers for the protection of the customer. Please call our business office if you would like access to the 900# network.

BEFORE YOU CALL, CONSIDER THE FOLLOWING

- When the Directory Assistance Operator answers, give the city or town, then the name and address you wish to call. Jot down the number for future reference.

EXCEPTIONS

Customers who cannot use the telephone directory because of physical, visual, mental
or reading conditions can be exempted from the Directory Assistance charge. Call your

Kansas Relay is a no-cost public service that enables people who are deaf, deafblind, hard of hearing or have speech disability who use a teletypewriter (TTY), captioned telephone, or other assistive device to communicate with family, friends or businesses with ease.

Hours of Services

All Relay and CapTel services are available 24 hours a day, seven days a week. However, Spanish CapTel is available from 7:00 am to 11:00 pm.

Captioned Telephone (CapTel)

The Kansas Captioned Telephone (CapTel) service is also available and ideal for people who have hearing loss but are able to speak for themselves. A captioned telephone works like any other telephone except captions on a screen. That allows people to listen to their phone conversations while reading word-for-word captions of what's said to them.

Speech-to-Speech (STS)

People with a speech disability, or those who use a voice synthesizer, can use their own voice on a STS relay call. The Communications Assistant is specially trained to understand unique speech patterns, repeats the words exactly as they are spoken to their caller.

Equipment Distribution Program

The Kansas Telecommunications Access Program (KS TAP) is an equipment distribution program. The purpose of the program is to provide free specialized telephones and other telecommunications devices to Kansans with disabilities who can't use traditional home telephones.

The equipment includes:

- Amplified telephone
- Captioned telephone (CapTel)
- · Speaker telephone
- Text-telephone device (TTY)
- Telephone equipment for deafblind

Reducing Unwanted Telemarketing Calls

Register for the Direct Marketing Association's Telephone Preference Service

You may register your residential telephone number(s) with the Direct Marketing Association's (DMA) Telephone Preference Service to be placed on this private organization's "Do Not Call" list. The Do Not Call list will be used by DMA member telemarketing companies to remove your telephone number from their calling lists. Telemarketers who participate in this private, voluntary program do not want to waste their time, or yours, by contacting you if you do not want to receive telemarketing calls.

Registration is good for up to five years. If you move or change your phone number during the five-year period, you will need to re-register. Registrations must be made with the Telephone Preference Service directly; third party requests cannot be processed.

How to register your telephone number(s):

Add your phone number for free by visiting donotcall.gov, or calling 1-888-382-1222 from the phone you want to register (TTY: 1-866-290-4236).

You may register for free by sending your full name, full address, signature and up to two telephone numbers to the following address:

Alternatively, you may register with the Telephone Preference Service on-line for \$5. The web address is www.thedma.org/cgi/offtelephonedave.

Registering with the Telephone Preference Service will not eliminate all telemarketing calls. Nonprofit/charitable organizations, political groups, non-DMA telemarketers or any groups that have established relationships with you may still contact you. Because the DMA's list is updated quarterly, it may take a few months before unwanted calls are noticeably reduced.

There are no penalties for telemarketers calling telephone numbers on the Do Not Call list. Also, registering for the list gives you no additional rights beyond those specified by the law.

For information about your legal rights regarding telemarketing, please see the section entitled "Telemarketing – Consumers' Rights and Remedies Under State and Federal Law."

SLAMMING PROTECTION

Many people around the country have had their long distance service switched to a different company without their knowledge or consent. Your telephone company opposes this unlawful practice, known as "slamming."

To help protect you from being "slammed" Wheat State Technologies offers an option to all local service customers: you may give us written directions not to change your long distance company without your signed authority. Consumer Information

TELEMARKETERS MUST OBEY STATE AND FEDERAL LAWS WHEN CALLING KANSAS RESI-DENTS. Violations can be enforced by the Attorney General or through a private cause of action.

TELEMARKETERS WHO MAKE UNSOLICITED CALLS TO RESIDENTIAL PHONE NUMBERS MUST:

- Identify themselves, the business for whom they are calling and the purpose of the call immediately upon making contact with the person being called;
- Promptly discontinue the call if the person being called indicates a negative response or desire to not listen at any time during the call (i.e. "just say no");
- ✓ Have a live or recorded voice respond within 5 seconds of answering the call;
- Make their phone number accessible to caller i.d. services if technically possible;
- ✓ Maintain internal "do not call" list and honor that request;
- ✓ Disclose whether the seller has a policy of not making refunds, cancellations, exchanges, or repurchases;

TELEMARKETERS MUST NOT:

 Use automatic telephone dialing systems or pre-recorded voice messages to call pagers, wireless phones or any service for which the party called is charged for the call.

- ✓ Send unsolicited advertisements to fax machines.
- ✓ Use threats, intimidation, profane or obscene language;
- Cause any phone to ring repeatedly or continuously for the purpose of annoying or harassing any person at the called number;
- ✓ Call before 8:00 a.m. or after 9:00 p.m. local time.

Exceptions are calls placed for non-commercial purposes, calls made for commercial purposes which do not include any unsolicited advertisements, calls to any person with whom the caller has established a business relationship, and calls from tax-exempt nonprofit organizations.



Communications services can literally be a lifeline that connects people to their communities. True to its name, the federal Lifeline program provides up to a \$9.25 monthly discount for eligible low-income subscribers on selected communications services from participating providers.* Wheat State Technologies (WST) participates in his program. WST offers Lifeline to qualifying persons with service in and around the following areas in rural Kansas; Cassoday, Matfield Green, Olpe, Potwin, Rock, and Udall.

To qualify to apply for a Lifeline discount, consumers must either have an income that's at or below 135% of the Federal Poverty Guidelines or participate in federal assistance programs such as the Supplemental Nutrition Assistance Program (SNAP), Medicaid, Federal Public Housing Assistance, Supplemental Security Income, the Veterans and Survivors Pension Benefit, or certain Tribal Programs. FCC rules prohibit more than one Lifeline service per household.


